# Environmental impact assessment directive: agreement reached with EU ministers.

MEPs and the Lithuanian Presidency of the Council reached an agreement on draft legislation aiming to better harmonise the way environmental impact assessments are carried out in the EU, on 20 December 2013. The draft legislation includes measures to enhance transparency, public participation and take new environmental factors such as biodiversity and climate into account. Owing to a strong minority of Member States exploration and extraction activities for non-conventional hydrocarbons are not included, but will be subject of another specific legislation instead.

# Industrial pollutant melted European glaciers.

According to a new study industrial emissions of black carbon were responsible for the retreat of the glaciers in the European Alps that marked the end of the so-called 'Little Ice Age'. The researchers explain how black carbon deposits could have caused glaciers to melt more rapidly from the mid-19<sup>th</sup> century and suggest that human activities were already having a visible influence on the climate before the effects of carbon dioxide were evident.

# North Atlantic Craton Conference 2014, University of St Andrews, Scotland, 20-21 March 2014.

The organising committee of the NAC Conference 2014 invites you to attend a two day conference on craton specific exploration targeting, using the North Atlantic Craton (NAC) as the area of interest. This workshop on the mineral potential of the North Atlantic Craton (NAC) as a whole is aimed at initiating and furthering trans-Atlantic collaboration in understanding the Archaean cratonic controls on ore deposit formation through time. The Archaean high-grade gneiss terrain of the NAC stretches from Labrador, Canada, through Greenland and into NW Scotland, UK. Acceleration in exploration efforts for various commodities across this region, particularly in Greenland, has highlighted the potential of its mineral resources. ### What are the impacts of depositing dredged sediment on the seafloor?

According to a recent study depositing dredged material on the seabed can significantly reduce the functioning of marine habitats, diminishing the amount of food available for fish and other animals further up the food chain. The author of the study calls for inclusion of this effect into environmental impact assessments of dredging.

### EP adopts CCS report.

In its plenary session on 14 January 2014 the European Parliament adopted the own-initiative report of MEP Chris Davies (ALDE, UK) on "developing and applying carbon capture and storage technology in Europe". According to the report Carbon Capture and storage (CCS) projects have the potential to allow the EU to meet its low-carbon goals, in particular for decarbonising high co2-emitting industries, and should receive more support from Member states and the EU.
