1 OBJECTIVE

To ensure that a Regulation Authority is established to support the EFG Council with procedures relating particularly to the awarding and maintenance of the European Geologist title, and the review and updating of EFG Statutes and Regulations.

2 SCOPE

This Regulation covers the actions of Council in appointing a Chairman and members of the Regulation Authority, and the actions of the Regulation Authority in relation to the award of the title of European Geologist and the review and updating of statutes and regulations.

3 RELATED REGULATIONS

- Regulation E3: National Vetting Committee
- Regulation E4: Licensed Bodies
- Regulation E6: Continuing Professional Development
- Regulation C1: Code of Ethics
- Regulation C2: Grievance and Disciplinary Procedures

4 ROLE AND RESPONSIBILITY OF THE REGULATION AUTHORITY

The Regulation Authority shall be appointed by Council and shall comprise:

- (i) A Chairperson; and
- (ii) Not more than four other members.

Three out of the five members of the Regulation Authority shall be European Geologists and members of a National Association that is a Licensed Body. Individual members of the Regulation Authority shall normally serve up to three terms of two years.

The Chairperson or a member of the Regulation Authority shall attend Council Meetings.

The Regulation Authority shall:

- (i) review of applications from National Associations to establish a National Vetting Committee and inform the EFG Council those National Associations that have established National Vetting Committees in accordance with the requirements of

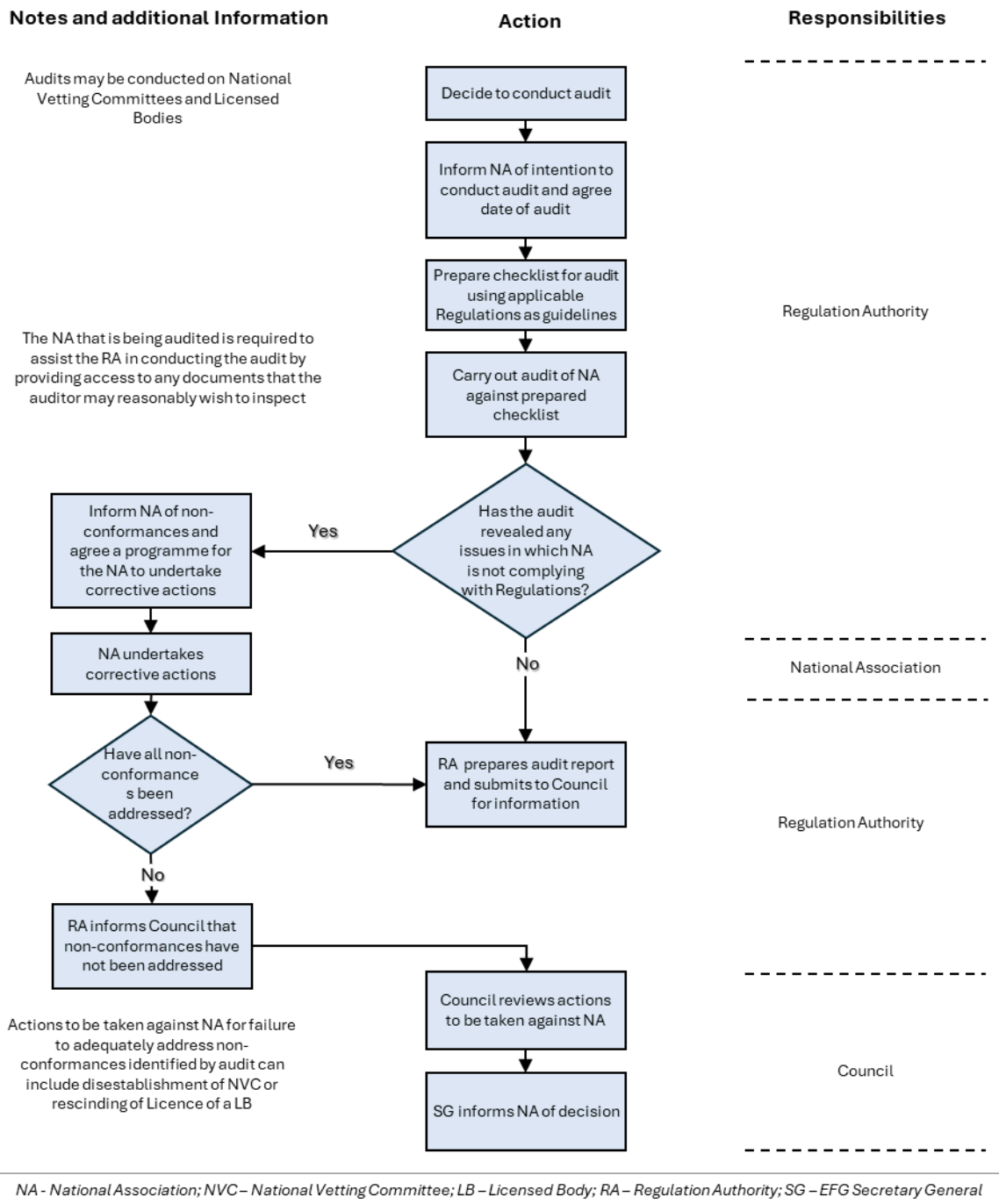
Regulation E3;

- (ii) Review of applications for establishment of Licensed Bodies and propose to the EFG Council the establishment of a Licensed Body or the renewal of the licence in accordance with the requirements of Regulation E4;
- (iii) maintain criteria for award of the title of European Geologist. These criteria shall be defined as Regulation E1 and subject to the approval of the EFG Council;
- (iv) maintain criteria for the establishment of a Licensed Body as defined in Regulation E4. These criteria shall be subject to the approval of the EFG Council;
- (v) carry out audits on National Vetting Committees and Licensed Bodies and report the results of these audits to the EFG Council;
- (vi) require National Vetting Committees and Licensed Bodies to take corrective actions to rectify any deviations from procedures defined in the Regulations that may have been identified by audit;
- (vii) propose to the EFG the disestablishing of any National Vetting Committees or rescinding of the licence of a Licensed Body if corrective actions arising from audits are not progressed or where, in the view of the Regulation Authority, procedures as defined in the Regulations are not being followed;
- (viii) receive reports from National Vetting Committees and Licensed Bodies on any matters dealt with under the Grievance and Disciplinary Procedures. Refer matters to the EFG Council that, in the view of the Regulation Authority, have not been dealt with in accordance with the Grievance and Disciplinary Procedures;
- (ix) report to the EFG Council on the activities of the Regulation Authority and present this report at EFG Council Meetings.
- (x) monitor activities of the EFG, the Council and the Board for compliance with the procedures set out in the Statutes and Regulations.
- (xi) maintain the Statutes and Regulations and suggest any revisions or amendments that become necessary. These suggestions should be submitted to the Council for approval.
- (xii) keep a watching brief on matters relating to the content and application of the Code of Ethics (Regulation C1), including responding to any questions on ethical matters. Where appropriate form a temporary Ethics Committee as a sub-committee of the Regulation Authority to consider any such matters.
- (xiii) Ensure that the EFG Statutes and all Regulations are regularly reviewed and updated to ensure processes and procedures follow best practice.

The Brussels Secretariat will provide secretarial support to the Regulation Authority as required.

5 PROCEDURE

5.1 Conduct of audits on National Vetting Committees and Licensed Bodies



6 RECORDS

The Regulation Authority is responsible for maintaining the following records:

- (i) applications received from National Associations to establish National Vetting Committees;

- (ii) applications for establishment of Licensed Bodies or for renewal of licence;
- (iii) a register of National Vetting Committees and Licensed Bodies including dates when they were established, licensed or relicensed.
- (iv) results of audits carried out on National Vetting Committees and Licensed Bodies, including records of actions taken to undertake corrective actions;
- (v) records of issues referred under the Grievance and Disciplinary Procedures related to applications for award of the title of European Geologist or disciplinary actions taken against European Geologists, and
- (vi) Review and updating of the EFG statutes and all EFG regulations.
